There have been substantial interests in the development of a new class of polymeric materials, known as liquid crystalline polymers, as substitutes for plastics currently in use. Liquid crystalline polymers possess a number of desirable properties including low density, low melt viscosity, improved tensile and impact properties, and processability. One area where these liquid crystalline polymers have been widely investigated is the development of new packing structures for the production of fibers and films. Typical examples of this work are in U.S. Pat. Nos. 4,098,783, 4,110,143, and 4,201,837. While these polymers are generally capable of being processed into useful articles, the retention of their anisotropic properties for an extended period of time under conditions which do not adversely affect processing is a continuing problem. This particularly holds true for the processing of these polymers into fibers and films from solution spinning systems. Such systems are generally based on the use of a coagulating liquid which traps the polymer in a fiber or film form. Since the coagulating liquid is generally supplied at an elevated temperature, it is necessary to have the liquid crystalline polymer be sufficiently stable to withstand these processing conditions. While this is generally true for current liquid crystalline polymers, the need to improve this stability is self evident. Polymer stabilization in general and stabilization of thermotropic liquid crystalline polymers in particular is difficult because of their low melt viscosity. Typically, this means that the liquids are metastable and tend to degrade rapidly and
